## INFORMATION LETTER

**Dear Colleagues,**

From April 20 to 22, 2026, the Margulan Institute of Archaeology together with Akhmet Baitursynuly Kostanay Regional University will host the International Scientific Conference for students and young scientists “Akhinzhanov Readings – 2026”.

The conference will cover the following thematic areas:

1. History of archaeological research in Kazakhstan. The role of personality in science;
2. Archaeology of the Stone Age and Paleometallic Period;
3. Kazakhstan in the Early Iron Age;
4. Archaeology of the medieval period;
5. Interdisciplinary research in archaeology;
6. Issues of ethnoarchaeology and Current problems of preservation and utilization of historical and cultural heritage.

Working languages of the conference: Kazakh, Russian and English.

The conference is planned to be conducted in-person with the option for remote participation through Zoom platform.

Participants' expenses are covered by the sending party.

Applications for participation are accepted until December 31, 2025.

The texts of the reports for publication are accepted until January 31, 2026.

All materials received later will be rejected.

Applications and abstracts will be accepted only on the conference website <https://archeo-agynzhan.kz/>

The articles and figures must be named with the last name and initials of the first author (Musaeva RS article.doc; Musaeva RS figure).

## Author Guidelines

Articles must be original, and previously published material cannot be repeated.

### Requirements for manuscript sections:

**1. Margins 2 cm; Times New Roman font, size 12, line spacing 1.15.** There should be no additional space before or after paragraphs.

**The total manuscript length** should not exceed 15,000 characters (including spaces), including tables, figure captions, and annotations. The bibliography is not included in this limit and is provided separately at the end of the article. The article should contain no more than 3 illustrations.

**2. Last name and initials** of the author(s) should be specified on the first page after the title of the paper.

**3.** Then, a detailed Abstract should be given (at least 150 words or 800 characters including spaces). The Abstract should include the following aspects of the paper contents: subject, topic, purpose of the work (specified if not fully disclosed in the title); methods of work (described if characterized by novelty or of interest from the viewpoint of the work); results of the work (major results, author's conclusions, original discoveries); conclusions can be accompanied by recommendations, assessments, suggestions, hypotheses described in the work. The following should be avoided in the Abstract: phrases duplicating the title of the work; descriptive generalizations, unnecessary introductory phrases (for instance, "the author of the paper is addressing..."), complex grammar structures; generally known provisions; information of a historiographic nature, if it does not constitute the main content of the work; the names of previously published works should not be given.

**4. Keywords** Up to 10 keywords should be given, facilitating the indexing of the paper in search engines. The keywords should reflect the main content of the paper and disclose the following aspects of the work: region, chronology, subject matter, special terminology.

**5. Bibliographic references to literature and sources** in the text are given in square brackets: the name of the author without initials (except for the works of namesakes) or a shortened name (if the publication does not have an author), the year of publication by comma; link to page, figure, etc. [Margulan 1948: 3; Akishev K.A. 1978; Akishev K.A., Akishev A.K. 1997: 35].

**6. References to the figures** are given in parentheses, the item position in the figure is indicated in italics: (рис. 1, 2; 2, *1*). Attribution of figures and the source from which the illustration was obtained must be explicitly stated.

**7. The list of literature** is compiled in alphabetical order (surname and initials of the author, title of the work, place, publishing house, year of publication, pages) in the original language. For collections, it is necessary to specify the responsible editor(s); for conference materials – the city, date of the conference, responsible editor. At the end of the article, a list of accepted abbreviations should be provided.

**Articles that do not meet the requirements will be rejected by the editorial board.**

In the article, it is necessary to highlight the structural elements:

**Introduction.** The author outlines the subject, objective, and tasks of the research. Formulates and theoretically justifies the hypothesis. Examines the relevance and extent of the problem's study. Overall, this section (Introduction) should convey to the reader what the author is investigating and why it is important.

**Research Methods.** This section should specify the methods used, materials, and equipment. Describes the experiment's scheme and conditions (if applicable). The section should be written in as much detail as possible and clearly to facilitate the replication of the experiment if desired.

**Discussion.** Interprets and generalizes the obtained results. Notes their alignment with the hypothesis. If applicable, mentions possible limitations in the applicability and interpretation of the author's research results.

**Results.** This section exclusively presents the results of the author's research. Results should align with the defined objectives and research methodology. To facilitate visual assessment, part of the information is presented in the form of tables, graphs, diagrams, and figures.

**Conclusion.** Offers conclusions based on a critical analysis of the author's results. This section should not provide a summary of the results; instead, it may suggest directions for future research.

**Acknowledgments.** As needed, express gratitude for consultations, assistance in preparing illustrations, providing specific information, photographs, etc.
